

FILLMORE CITY RESOLUTION NO. 23-18

**A RESOLUTION OF THE CITY OF FILLMORE, UTAH CANCELLING THE 2023
MUNICIPAL GENERAL ELECTION**

RECITALS

WHEREAS, the pursuant to Section 20A-1-202 of the Utah Code Annotated, as amended Fillmore City is required to hold an election for the election of persons to the Fillmore City Council and Mayor; and

WHEREAS, all municipal officers are elected in an at-large election; and

WHEREAS, with respect to the 2023 election, the number of candidates for at-large positions does not exceed the number of open at-large municipal offices for which the candidates have filed; and

WHEREAS, there are no other municipal ballot propositions to be submitted for election; and

WHEREAS, Section 20A-1-206 of the Utah Code Annotated, as amended, authorizes the Fillmore City Council to cancel the municipal election due to the foregoing circumstances; and

WHEREAS, the Fillmore City Council has determined that cancellation of the election will eliminate unnecessary expenses and will be in the best interest of the public;

NOW THEREFORE, be it resolved by the City Council of the City of Fillmore, Utah:

Section 1. Enactment. Eugene Larsen, Kyle Stevens, and Michael Winget are the only people that have filed for the three open 4-year councilmember positions on the Fillmore City Council and are therefore unopposed. Accordingly, the Fillmore City Council hereby declares the aforementioned to be elected to their respective positions with their respective terms to commence at 12:00 p.m. on the first Monday in January following the election.

Section 2. Enactment. The Fillmore City Council hereby cancels the 2023 municipal election for Fillmore City and directs the City Recorder to give notice of cancellation of the municipal election for 2023 as follows:

- A. Posting notice on the Statewide Electronic Voter Information website for 15 consecutive days before the day of the scheduled election.
- B. Providing notice for the municipality, as a class A notice under Section 63G-30-102, for at least 15 days before the day of the scheduled election
- C. Submitting a signed copy of this resolution to the Millard County Clerk's office and to the State of Utah Lieutenant Governor's Office.

Section 3. Effective Date. This resolution shall become effective upon adoption.

Section 4. Severability. To the extent that any resolutions or policies of Fillmore City conflict with the provisions of this resolution, they are hereby amended to be in accordance with the provisions hereof.
