Commissioner Lyman said the invocation. Everyone stood and said the Pledge of Allegiance to the Flag.

Commissioner Wright presented a thank you note that was given by the care center in appreciation of the Commission's support.

APPROVAL OF NOVEMBER 19, 2024 COMMISSION MINUTES

The proposed minutes of a regular County Commission meeting held November 19, 2024 were presented for consideration and approval. Following review, Commissioner Wright made a motion to approve the minutes of November 19, 2024, as presented.

Commissioner Johnson SECONDED the motion. The voting was unanimous and the motion carried.

DISCUSSION AND POSSIBLE APPROVAL OF THE HOLIDAY CLOSURES CALENDAR FOR 2025

Auditor Smith presented the holiday closures calender for 2025.

Commissioner Johnson made a motion to approve the holiday closures calender for 2025. Commissioner Wright SECONDED the motion. The voting was unanimous and the motion carried.

DISCUSSION AND POSSIBLE APPROVAL OF A CONTRACT WITH MIDWAY CARNIVAL ATTRACTIONS FOR THE MILLARD COUNTY FAIR

Director West presented the contract with Midway Carnival Attractions for the Millard County Fair. She explained that they are based out of Cedar City and do provide their own insurance.

Commissioner Johnson asked about adding a softball tournament.

Commissioner Johnson made a motion to approve the contract with Midway Carnival Attractions for the Millard County Fair.

Commissioner Wright SECONDED the motion. The voting was unanimous and the motion carried.

DISCUSSION AND POSSIBLE APPROVAL OF RESOLUTION 24-12-03, A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MILLARD COUNTY, UTAH, AUTHORIZING THE MILLARD COUNTY TREASURER TO MANAGE AND ADMINISTER INVESTMENTS IN THE UTAH PUBLIC TREASURERS INVESTMENT FUND

Interim Treasurer Camp explained that this resolution to enable her and her deputy to manage the Fund.

Commissioner Johnson made a motion to approve Resolution 24-12-03, a resolution of the Board of County Commissioners of Millard County, Utah, authorizing the Millard County Treasurer and Deputy to manage and administer investments in the Utah Public Treasurers Investment Fund.

Commissioner Wright SECONDED the motion. Clerk Rowley called for a roll call vote. Commissioner Johnson voted YES. Commissioner Wright voted YES. Commissioner Lyman voted YES. The voting was unanimous and the motion carried.

DISCUSSION AND POSSIBLE APPROVAL OF A SOLE SOURCE PURCHASE FOR TWO LUCAS CPR DEVICES FROM STYKER MEDICAL

Supervisor Mitchell explained why they require the sole source purchase of two Lucas CPR Devices from Styker Medical. She explained that the Tourism Department is donating \$31,000.00 to the EMS Department and this would allow two devices to be stored on both the east and west side of the County. She said that it would cost \$38,500.00. She also explained the benefits these devices bring to EMS runs.

Commissioner Wright made a motion to approve the sole source purchase of two Lucas CPR Devices from Styker Medical.

Commissioner Johnson SECONDED the motion. The voting was unanimous and the

motion carried.

OTHER BUSINESS

Clerk Rowley presented a business license for Southern Utah Machine for approval. She explained that it was received a few months ago but they were waiting for their sales tax to show a Millard County address.

Commissioner Johnson made a motion to approve the business license for Southern Utah Machine.

Commissioner Wright SECONDED the motion. The voting was unanimous and the motion carried.

This license will be ratified during the next commission meeting.

Auditor Smith explained that a sole source service provided by Dixie Power is required to run hookups for the Tourism billboard in the amount of \$1,570.00.

Commissioner Johnson made a motion to approve the sole source service provided by Dixie Power.

Commissioner Wright SECONDED the motion. The voting was unanimous and the motion carried.

Auditor Smith presented a list of thirteen surplus items that were transferred from the Road Department to the Landfill Department in 2023. She explained that the Road Department is requesting a refund for the items in the total amount of \$13,000.00.

Commissioner Wright made a motion to approve the transfer of funds in the amount of \$13,000.00 to the Road Department.

Commissioner Johnson SECONDED the motion. The voting was unanimous and the motion carried.

Commissioner Lyman explained that it has been brought to her attention that unauthorized people are filling large water tanks at the RV parks. The RV parks are requesting signage against such action. She said that she will follow through on the situation.

Commissioner Lyman also explained that four AC units need to be installed on the roofs at the Road Barn and the Road Department wants the provider to install them, which will cost \$13,000.00. She said that she is asking for approval for installation in March of 2025.

Commissioner Wright made a motion to approve installing the AC units.

Commissioner Johnson SECONDED the motion. The voting was unanimous and the motion carried.
