

FILLMORE CITY RESOLUTION NO. 25-10

A RESOLUTION OF THE CITY OF FILLMORE, UTAH CANCELLING THE CITY COUNCIL RACE FOR THE 2025 MUNICIPAL GENERAL ELECTION

RECITALS

WHEREAS, the pursuant to Section 20A-1-202 of the Utah Code Annotated, as amended Fillmore City is required to hold an election for the election of persons to the Fillmore City Council and Mayor; and

WHEREAS, all municipal officers are elected in an at-large election; and

WHEREAS, with respect to the 2025 election, the number of candidates for city council positions does not exceed the number of open city council municipal offices for which the candidates have filed; and

WHEREAS, Section 20A-1-206 of the Utah Code Annotated, as amended, authorizes the Fillmore City Council to cancel the city council race of the municipal election due to the foregoing circumstances; and

WHEREAS, the Fillmore City Council has determined that cancellation of the city council race of the election will eliminate unnecessary expenses and will be in the best interest of the public;

NOW THEREFORE, be it resolved by the City Council of the City of Fillmore, Utah:

Section 1. Enactment. Dennis Alldredge is the only person that has filed for the two open 4-year councilmember positions on the Fillmore City Council and is therefore unopposed. Accordingly, the Fillmore City Council hereby declares the aforementioned to be elected to their respective position with their respective term to commence at 12:00 p.m. on the first Monday in January following the election.

Section 2. Enactment. The Fillmore City Council hereby cancels the city council race of the 2025 municipal election for Fillmore City and directs the City Recorder to give notice of cancellation of the municipal election for 2025 as follows:

- A. Posting notice on the Statewide Electronic Voter Information website for 15 consecutive days before the day of the scheduled election.
- B. Providing notice for the municipality, as a class A notice under Section 63G-30-102, for at least 15 days before the day of the scheduled election
- C. Submitting a signed copy of this resolution to the Millard County Clerk's office and to the State of Utah Lieutenant Governor's Office.

Section 3. Effective Date. This resolution shall become effective upon adoption.

Section 4. Severability. To the extent that any resolutions or policies of Fillmore City conflict with the provisions of this resolution, they are hereby amended to be in accordance with the provisions hereof.
