- The Declaration of Intent to Gather Signatures period for qualified political party candidates begins on Tuesday, January 2, 2020 and ends at 5:00 pm., Thursday, March 19, 2020, and;
- Candidates must submit nomination petition signatures no later than 14 days before the day on which the qualified political party holds its convention to select candidates for the elective office and;
- The Declaration of Candidacy filing period for qualified political party candidates begins on Friday, March 13, 2020 and ends at 5:00 p.m., Thursday, March 19, 2020, and;
- The Declaration of Candidacy filing period for state and local school board candidates begins on Friday, March 13, 2020 and ends at 5:00 p.m., Thursday, March 19, 2020, and;
- The Declaration of Candidacy filing period for justices and judges of a court of record begins Wednesday, July 1, 2020 and ends at 5:00 p.m., Wednesday, July 15, 2020.
