PURSUANT TO AN AGENDA WHICH HERETOFORE HAD BEEN PROVIDED TO each member of the governing body, the local news and located on the front and back doors of the County Courthouse as required by law the following proceedings were had.

COORDINATION SESSION

The Commissioners scheduled events for the months of March and April 2006.

PUBLIC WAS WELCOMED

The meeting began at 10:00 a.m. after a brief welcome by Commissioner Walker to the public and Commission members.

OPENING STATEMENTS

Commissioner Walker asked if anyone had an opening statement to give? Commissioner Smith said the invocation. Everyone stood and said the Pledge of Allegiance to the Flag.

FOLLOW UP ACTION ITEMS FROM MINUTES OF FEBRUARY 2006

There were none.

APPROVAL OF THE AMENDED MINUTES OF FEBRUARY 2006

Commissioner Smith made a motion to approve the amended minutes of February 13, 2006 and Commissioner Cooper SECONDED. The voting was unanimous. The motion carried.

AUDITORS REPORT

Auditor Brandy Grace gave the Commissioners various invoices to review and approve for payment through the Auditor's Office.

Auditor Grace gave the Commissioners the Check Edit Report of February 24, 2006 to review and sign. The payroll report of February 17, 2006 was given to the Commissioners for review.

Auditor Grace said the IHC January billing was received for the care center for \$171,213.11 and for the Fillmore Hospital, \$23,950.00. The December billing has not been paid because negotiations are still going on between IHC and Millard County on the ground lease. The Commissioners decided to not pay the January bill until after the meeting with IHC on March 28, 2006.

Auditor Grace said the Sheriff Office had budgeted \$150,000.00 in capital funds for the in-car videos. An invoice from Motorola for \$107,795.00 had come in and when it is combined with a paid invoice of \$46,500.00, it becomes over budget. The Commissioners will talk to the Sheriff and see which account the balance of the money should be taken from.

A billing from Servo for \$2,491.34 for the boiler repair has come in and another one for approximately \$50,000 will be coming in. Auditor Grace suggested that the money be taken out of West Millard Recreation repair budget as no money had been budgeted for that line item. Later the budget will need to be opened up and increase funds for Fund 46.

Cellular One sent the county notice that some cell phone lines are no longer under contract and need to be renewed. Cellular One is merging with Alltel and suggested the contract be renewed prior to March 6. Any cell line ready for renewal could receive a new phone at the cost of \$9.95 each. The Commissioners agreed to continue cell phone service with Cellular One. Auditor Grace will send out a memo to each elected official/ department head letting them know of the Commissioners' decision to go with Cellular One if they choose to participate.

The minutes of October 24, 2005 shows that a motion was made to pay \$15,000 less \$500.00 to Robert K. Weidner who serves as Millard County's Washington lobbyist. There was no mention of a letter being sent. Mr. Weidner did not receive his check. Another check will be issued and the Commissioners will explain the circumstances to Mr. Weidner during their Washington visit during the first part of March.

Delta City Mayor Bunker said he was sending the law enforcement contract payment that had been calculated by using the amount paid last year and adding the 3% COLA. This would be all they would pay until Delta City and the Commissioners came to an agreement about the office space. Auditor Grace said that this is not the contract amount sent to them. Commissioner Walker will schedule a meeting after March 10, 2006 with Delta City for the Commissioners and Attorney Jackson to discuss any concerns.

Auditor Grace said that the changes in regards to pay with special circumstances should be addressed in the Millard County Policies and Procedures Manual. The Commissioners and the Auditor will review current policy and make any clarifications necessary.

Auditor Grace said people are already asking for some consideration in regards to their taxes on properties that will be included on the upcoming tax sale. The Auditor and Treasurer would like to meet with the Commissioners to discuss what plans they have in regards to what consideration may be given to tax payers. Auditor Grace and Treasurer Hansen will meet together after the meeting today.

Commissioner Smith gave the Auditor the Central Utah Mental Health Authority Board audit.

#### REVIEW AND POSSIBLE ADOPTION TO AMEND SECTION XV OF THE MILLARD COUNTY POLICIES AND PROCEDURES MANUAL - MOTORIZED EQUIPMENT AND VEHICLE POLICY

Attorney LeRay Jackson said that changes have been recommended to bring the current motorized equipment and vehicle policy up to date.

Commissioner Cooper made a motion to adopt the amendment to Section XV of the Millard County Policies and Procedures Manual - Motorized Equipment and Vehicle Policy.

Commissioner Smith SECONDED the motion. The voting was unanimous. The motion carried.

#### REVIEW AND POSSIBLE ADOPTION TO AMEND THE MILLARD COUNTY FACILITIES USE AND RENTAL POLICY

Attorney Jackson said one change has been made on page 4. A copy will be e-mailed to the Auditor and she will circulate them to the various department heads and elected officials.

Commissioner Smith made a motion to adopt the amendment to the Millard County Facilities Use and Rental Policy.

Commissioner Cooper SECONDED the motion. The voting was unanimous. The motion carried.

#### REVIEW AND POSSIBLE ADOPTION TO AMEND SECTION X D. OF THE MILLARD COUNTY POLICIES AND PROCEDURES MANUAL - DEFINITION OF AN IMMEDIATE FAMILY MEMBER UNDER SICK LEAVE

Commissioner Cooper made a motion to accept the definition of an immediate family member under sick leave.

Commissioner Smith SECONDED the motion with discussion. The voting was unanimous. The motion carried.

## POSSIBLE APPROVAL OF A BUSINESS LICENSE FOR NATURE'S HARVEST-NOLA CHARLESWORTH

Commissioner Smith made a motion to approve the business license for Nature's Harvest - Owner Nola Charlesworth.

Commissioner Cooper SECONDED the motion. The voting was unanimous. The motion carried.

## APPOINTMENT OF AN INTERIM MILLARD COUNTY SHERIFF

Commissioner Walker said that public comment would be taken in regards to the upcoming appointment for an interim Millard County Sheriff and she invited people who wanted to make comments to come to the microphone and state their name for the record.

**Keith Burris** said that he is concerned that any candidate appointed to the interim sheriff position would appear to have the endorsement of the county commissioners in the up coming election.

Commissioner Walker said that the law will be followed in making the appointment of the interim sheriff.

Pursuant to Utah Code Annotated, Section 20A-1-508(6)(a) and (b) since said office has an unexpired term of less than two (2) years and Sheriff Phillips was elected as a Democrat, the central committee of the Democrat Party was invited to submit the names of three (3) nominees to fill the vacancy. The nominees shall each meet the requirements as outlined in Utah Code Annotated 17-22-1.5. This shall be done within thirty (30) days of the date of February 28, 2006. The central committee was asked to submit the names to the Millard County Commission by twelve o'clock noon on Friday, February 24, 2006, in order that an appointment to fill the vacancy can be made at the regularly scheduled commission meeting to be held on Monday, February 27, 2006 and that appointed person could be sworn to fill such vacancy on February 28, 2006.

If the committee cannot meet the February 24, 2006-deadline, thereafter, and within forty-five days after the vacancy occurs the county legislative body (Millard County Commission) shall appoint one of those nominees to serve out the unexpired term.

**Keith Burris** said that there were others beside himself out there that may view this as an endorsement for Sheriff.

**Dan Bringard** said that an article could be put in the newspaper to let the public know that the Commissioners do not view this appointment as an endorsement for the position of Millard County Sheriff in the upcoming election.

Commissioner Walker read letters from Roger Killpack and Democratic Chairman Jim Dewyze. (See Exhibits A & B).

Robert Dekker turned in a copy of his resume and a letter to the Commissioners that stated he still intends to run for the Office of Sheriff in the upcoming election. He believes that he is well

qualified for the position and he will fulfil the duties of the office to the best of his abilities. He thanked the Commissioners for their kind consideration. (See Exhibit C).

Commissioner Cooper made a motion to appoint Robert Dekker to serve as the interim Millard County Sheriff for the remainder of the year 2006. He is the only candidate for this interim position nominated by the Democratic party. This not an endorsement of the Millard County Commissioners in anyway for the position of sheriff in the upcoming election.

Commissioner Smith SECONDED the motion and stated that the Democratic Party could have submitted three names of qualified applicants. One name was submitted and the Commissioners appreciate that. Due to the circumstance that Sheriff Phillips has resigned this will be a transitional period and the work will continue on. This is the same process that has been used in the past in other county offices when a position has been vacated. The process works very well. The voting was unanimous. The motion carried.

Commissioner Walker congratulated Robert Dekker on his appointment to this position. The swearing in ceremony will take place on February 28, 2006 at Sheriff Phillips retirement party at approximately 6:30 p.m.. The appointment will be effective at 12:01 a.m. March 1, 2006.

#### DISCUSSIONS FROM EACH COMMISSIONER, COUNTY ATTORNEY, AND ELECTED OFFICIALS, AND SECRETARY

Commissioner Cooper, Commissioner Smith, Commissioner Walker and Sheryl Dekker attended the Council of Governments meeting on March 15, 2006.

Commissioner Cooper visited with Udell Sorensen about the poor TV reception in Scipio. Dee Hollingshead was contacted and will check out the reception problems.

Commissioner Cooper talked to Julie Robison about a mile stretch of road where the Flowell Highway connects with the Clear Lake Road. There are houses along this road as well as a lot of truck traffic. The road has been sprayed with Mag Chloride and the homeowners would like to see it chipped sealed. The Commissioners will take a tour of the road and will consider putting money in next year's budget for the road improvements if warranted.

Commissioner Cooper talked to Brad Shafer from UAC who had talked to Mike Styler who said the state will give Millard County technical support but not legal support in the Southern Nevada Water Hearings. Millard County will need to file for some help with the Constitutional Defense Council.

On Thursday, February 16, Commissioner Smith and Commissioner Cooper attended the Legislature Committee meeting to oppose Senate Bill 054. The State of Utah is trying to take more of the revenue collected from speeding tickets throughout the state. Currently the state takes 22 percent of the revenues and the bill would allow the state to collect 50 percent. The bill made it thru the House and Senate and was up for voting on the floor.

Commissioner Smith, Recorder Connie Hansen and GIS Tech Adam Britt attended a meeting with Jim Edwards, Edwards Surveying to discuss the progress on the contracted project of finishing the corner sections for the rest of the county.

On February 22, Juab Commissioners, Millard County Commissioners, State Department of Water Resources Mike Styler, Larry Anderson, Jerry Olds and Robin Pearson met together. The state's position on water issues were explained, mainly the Colorado River water compact and its relationship to the Nevada pipeline. Commissioner Smith expressed Millard County's appreciation for the state's help. They gave assurance that they are supporting the Governor's commitment to continue to protect the life style and resources of Utahns in the affected area. The state has drafted two letters to be sent to the State of Nevada and Millard County was asked if they had any more input.

Commissioner Smith and Attorney Brent Berkley attended the Central Utah Mental Health Authority Board meeting on February 22, 2006. Minutes of the meeting are available for interested parties.

On February 23, 2006, Commissioner Smith attended the Western Counties Alliance Board meeting in Salt Lake City, Utah. Uintah County Commissioner Mike McKee was elected to serve as the president with Mike Havershaw as the Vice President for a one year term. There were thirteen of the forty-four counties throughout the western states represented at the meeting. Fifteen counties had official letters to join the group until a letter from WIR requesting that they not join. This issue will be addressed at the NACO Conference in Washington D.C. in March.

President Bush has requested a decrease in the budget for 2007 which will decrease the PILT payment. The 2006 PILT payments will be adjusted with a 1 percent reduction giving Millard County \$769,319.00.

The Western Counties Alliance Board is still in the developmental stages and most of the future meetings will be conference calls.

Commissioner Smith reported that the road department is installing a cattle guard near the Indian Reservation that was requested by Meadow Town.

The road department has been hauling lime chips on the road to help build up the road base where the two highways meet. They are moving the crusher out on the west desert.

Commissioner Smith reported that he and Thayne Henrie had gone over the chemical bids and the tire bids and determined which was the best value for the county. Steve Regan was awarded the chemical bid and Steve's Tire was awarded the tire bid.

All the Commissioners will be attending the NACO Conference in Washington D.C. on March 3, to March 8, 2006. Commissioner Cooper serves on the Public Lands Committee and Commissioner Smith serves on the Agricultural and Rural Affairs Committee. Commissioner Walker will work on getting appointed to the Economic Development Committee. They will be listening to information on other issues affecting the county. The Commissioners have set up dates to talk to the Congressional Delegations and other federal offices to talk about the comprehensive land use plan and water issues.

Commissioner Smith said he will be traveling with his son Spencer whose trip is being paid for by Commissioner Smith. Spencer will be staying with his grandmother who lives near Washington D.C..

Commissioner Walker met with Captain Robert Dekker to discuss plans for Sheriff Ed Phillips retirement party, which will be held Tuesday, February 28, 2006 from 4-7 p.m..

Commissioner Walker met with Peggy Harrison of Congressman Cannon's staff and Maureen Casper of Senator Hatch's staff on February 15, 2006 to visit Delta area business owners/managers. That evening Commissioner Walker conducted the Council of Governments meeting in Delta with approximately 20 in attendance, including new mayors from Oak City Town, Mayor Mike Staheli and Fillmore City, Mayor David Christensen.

Commissioner Walker, Commissioner Cooper and Economic Development Director Gary Church attended the Six-County Business Recognition Banquet in Richfield on February 16, 2006. Alan and Lori Roper of Fillmore were honored as Millard County's Business of the Year recipients. They have been in business for twenty-nine years. Their businesses include the lumber business, leasing, motel and agricultural business including an apple orchard.

Dale Roper of Delta was also honored for his years of service on the Six-County Economic Development Board.

All three Commissioners, Auditor Brandy Grace, County Attorney Jackson and Sheryl Dekker met at the Millard County Care Center on February 17. Also, in attendance were Millard County Care Administrator Nancy Schmid, IHC Accountant Chris Thompson, and Hospital Administrator Jim Beckstrand. Options to reduce current operating costs to the county at the Millard County Care Center were discussed. Another meeting will be held March 28, 2006.

Commissioner Walker and Commissioner Smith met with Cosmic Ray representatives Kai Martens and Pat Shea on February 20, 2006 to discuss the placement of detectors on private land for the Telescope Array project west of Hinckley. An open house will be held Monday, March 20, at the Cosmic Ray Observatory building in Delta.

Randy Johnson met with all three county commissioners on February 21, 2006 to brief them on Washington County's land use bill, which will be introduced into Congress by Senator Bennett. Discussion also took place on writing legislation for Millard County's land use bill and appointments were made to meet with key officials in Washington D.C. during the NACO convention March 3-8, 2006.

Commissioner Walker met with Fillmore Area Chamber of Commerce officers to clarify the procedure of accounting for funds received from Millard County Tourism. She also met with Tourism board member Gayle Cluff to address concerns and answer questions of how tourism funds are to be appropriated according to state law.

Commissioner Smith, Commissioner Walker, Commissioner Cooper and Juab County

Commissioners Bob Steele and Neil Cook met in Nephi on February 22 with Mike Styler, Deputy Director Robin Pearson, State Engineer Jerry Olds and Water Resource Director Larry Anderson. A history of the Southern Nevada Water Authority's need for water was given, including their desire to open the Colorado River compact and their need to develop in-state water resources.

Governor Huntsman asked Director Styler to write a letter to the Nevada State Water Engineer requesting the protest period be reopened on applications filed by SNWA more than 15 years ago. The Governor agreed with Millard County Commission that reopening the protest period would allow the State of Utah to file as a protestant.

Mike Styler said he was willing to write the letter, if the commissioners still wanted it written. However, it was Jerry Olds recommendation that the letter not be written because he didn't think Utah should interfere with Nevada State's administrative duties. Millard County and Juab County Commissioners agreed that the letter should be written and sent as was previously agreed upon with the Governor.

Commissioner Walker and Commissioner Cooper made a trip to West Desert High School on February 22, 2006 for a meeting. However, due to some misunderstandings they missed the meeting, which was being held at the Callao School instead.

Commissioner Walker attended the Sunset View Golf Committee meeting on February 23, 2006. Afterward, she met with Miss Millard Scholarship Pageant Director Lynnette Madsen to get an update for the August 5, 2006 Miss Millard Pageant.

Miss Millard Christie Peterson will represent Millard County at the Miss Utah Pageant on July 8, 2006. She needs opportunities to participate as a speaker or perform in as many events or activities as possible before the state pageant. County residents are asked to call Director Lynette Madsen for additional information.

## OTHER BUSINESS

Dan Bringard a business owner in Delta and representing the Desert Dog Jeep Club brought to the Commissioners a proposal of building an obstacle course at the Millard County Fairgrounds for jeep rodeos. They feel it could bring more business into Millard County and provide some fun recreation to locals and others. The course could be used by any group wishing to use it for fun, fund raisers or for training purposes. He provided sketches of different course ideas that could be built. He said people are willing to donate labor to build the jeep rodeo course, telephone poles, old tires and other materials would be used. Cement companies will be invited to dump extra cement in designated areas. Materials for the teeter-toter, the balance beam would need to be built or purchased. They could set up a course for use in about 2-3 acres. Estimated costs are about \$30,000 range. in certain areas. At the 2005 Millard County Fair they had set up a rock pile and held a small jeep rodeo. They have talked with Kevin Morris, West Millard Maintenance and he is willing to help. They would like to get started right away with the Commissioners' approval.

Keith and Jerry Shurtz handed out some information to the Commissioners about the Moab Jeep Safari. Mr. Shurtz said that Millard County has some very good natural areas that could be used in addition to the permanent course at the fairgrounds. A jeep rodeo could bring in people to stay



in the motels, eat at the restaurants and purchase part for repairs. It could grow into some very good for the Millard County.

Commissioner Smith made a motion to approve the Notch Peak Desert Dogs Jeep Club to go ahead and expand the rock course at the fairgrounds under the direction of maintenance supervisor Kevin Morris. They will be bringing in donated materials to help build the course. Hopefully this course will help promote tourism in Millard County.

Commissioner Cooper SECONDED the motion. The voting was unanimous. The motion carried.

The Commissioners invited Mr. Bringard and Mr. & Mrs. Shurtz to contact Roger Killpack to get on the Millard County Tourism agenda.

Commissioner Walker reported an invoice for \$948.00 from the Nevada State Natural Resources to defray the cost of the transcript fees had come in. Millard County's portion of the bill is \$35.00.

Commissioner Cooper made a motion to pay Nevada \$35.00 which is Millard County's share the court transcript costs.

Commissioner Smith SECONDED the motion. The voting was unanimous. The motion carried.

Commissioner Walker read a letter from the Governor's Office of Economic Development stating that the Delta Enterprise Zone expansion has been approved. All eligible businesses within the enterprise zone are eligible for tax credits under the program.

Commissioner Walker received an e-mail from Peggy Harrison from Congressman Chris Cannon's Office about opposition to wild and scenic river designation. Congressman Cannon has sent out a letter expressing opposition for Emery County. Commissioner Walker will contact Congressman Cannon's Office and request that he send a letter of opposition for Millard County in regards to Corn Creek in Millard County being designated as a wild and scenic river.

Commissioner Smith talked with Zach at the AGRC about the one foot natural color imagery that the state could provide for the county. The cost is \$150.00 a square mile and there is a 20 square mile minimum. Commissioner Smith told the State that Millard County is interested in working up an agreement with them. The money will be taken out of public lands and then the cost shared with the cities and towns.

Commissioner Smith made a motion for the county to renew their membership with Western Counties Alliance for \$7,500.00.

Commissioner Cooper SECONDED the motion. The voting was unanimous. The motion carried.

Attorney LeRay Jackson said that apparently the March 20, 2006 Commission meeting will need to be cancelled because of the Cosmic Ray open house that same date. The hearing on the Conditional Use Permit Appeal date will need to be changed from March 20, 11:00 a.m. to March 27, 11:00 a.m.. Janice Robins, Commission Secretary was asked to write letters to the interested

parties and put a notice in the newspaper.

Commissioner Cooper said the Commissioners are invited to a conference on immigration reform held during the NACO Conference on March 6 10:30-12:30 p.m.. A conference call on will take place on March 2, 2006.

On March 16-17 a Utah Waste Water Association Conference will be held. Gary Church and Wade Tolbert will be invited to attend.

#### PUBLIC INPUT

Fillmore City Mayor David Christensen asked if the county still rented out their large tent for community events? The Commissioners explained that the large tent had been sold to Delta City because of its costly repairs each year. Millard County has two smaller tents that can be rented out for \$25.00 each. Arrangements can be made with Max Wood at the recreation department.

#### POSSIBLE CLOSED MEETING PURSUANT TO UTAH CODE ANNOTATED SECTION 52-4-4&5

There were none.

#### WHERE UPON THE MEETING ADJOURNED

Commissioner Cooper made a motion to adjourn the meeting.

Commissioner Smith SECONDED the motion. The voting was unanimous. The motion carried. The meeting adjourned at 12:10 p.m..

Dear Mr. DeWyze,




Dear Mrs. Walker:


