PUBLIC WAS WELCOMED

The meeting began at 10:00 a.m. after a brief welcome by Commissioner Whatcott to the public and Commission members.

OPENING STATEMENTS

Commissioner Whatcott asked if anyone had an opening statement to give. Commissioner Whatcott said the invocation. Everyone stood and said the Pledge of Allegiance to the Flag.

PUBLIC HEARING FOR THE PURPOSE OF RECEIVING PUBLIC COMMENT ON POSSIBLY OPENING AND AMENDING THE FOLLOWING FUND BUDGETS: GENERAL FUND AND CAPITAL PROJECTS FUND

Commissioner Withers made a motion to enter into a public hearing for the purpose of receiving public comment on possibly opening and amending the following fund budgets: General Fund and Capital Projects Fund.

Commissioner Whatcott stepped from the chair and SECONDED the motion. The voting

Auditor Grace explained that the statute allows for an amount that can be carried over in the General Fund Balance. Due to new growth and other factors, the county currently exceeds the fund balance limitation.

The purpose of the resolution is to allow for the transfer of funds from the General Fund into the Capital Projects Fund. It is anticipated to transfer \$1,500,000.00 from the General Fund into the Capital Projects Fund.

Commissioner Withers made a motion to go out of the public hearing.

Commissioner Whatcott stepped from the chair and SECONDED the motion. The voting was unanimous and the motion carried. The public hearing closed at 10:11 a.m..
